The Green Bay 600 Bowling Club is conducting a **Mail-O-Graphic** singles tournament for its members. This tournament will begin Sunday, October 24 and run through Saturday, November 6, 2021.

**The entry form, with entry fee(s) must be returned to the above address postmarked no later than October 23, 2021.** League scores bowled from October 24 through November 6, 2021, will be used. You may enter in each league that you are a member, however, entrant may cash only once in the division entered. The score verification form must be returned postmarked no later than Thursday, November 11, 2021. **PLEASE REMEMBER TO INCLUDE A COPY OF YOUR LEAGUE RECAP SHEET WITH SIGNED VERIFICATION FORM.**

Open to USBC National 600 Club and GREEN BAY 600 CLUB MEMBERS who are associate members in the USBC. GREEN BAY 600 CLUB MEMBERSHIP may be obtained by including the \$5.00 membership fee with your entry blank. **Anyone who has bowled a 600 series in her bowling career**, but has not yet received her card can compete upon showing proof of her 600 series. Handicap for all Divisions is 90% of 225 scratch, based on highest USBC sanctioned league average of 21 games or more for the 2020-2021 season. If no 2020-2021 average, use highest sanctioned league average of 12 games or more as of October 23, 2021. If neither apply, the 2019-2020 book average will be accepted. (APPROVED BY TOURNAMENT DIRECTOR). This average, accompanied by verification must be presented with entry. Incorrect average will result in disqualification according to USBC RULE 319a-3. The ten (10) pin increase provision of USBC RULE 319a-2 and reporting of prize winnings, USBC RULES 319d and 319e are not in effect.

**PRIZE FUND WILL BE RETURNED 100% RATIO: At least 1 out of 4 entrants**

Awards will be presented to the First Place winner in each Division. Prizes for high scratch series and high scratch game in each Division of the Tournament will also be awarded.
