

# **GREEN BAY AREA USBC HALL OF FAME MERITORIOUS SERVICE NOMINATION FORM**

## PREREQUISITE FOR NOMINATION:

- Actively participated in the Green Bay Area USBC (or predecessor organizations) for a minimum of 20 years and reached the age of 50 (deceased members are exempt).

To qualify for meritorious service a candidate must have met the prerequisite above and have rendered exceptional service by accomplishing **at least 4 of the following**:

1. Served as local association officer or director for a minimum of 12 years.
2. Served as a chairperson for a committee in the association for a minimum of 6 years.
3. Served or worked in any capacity for state, national, or local association tournaments. Minimum of 10 events.
4. Served and attended as delegate to the state or national annual meetings. Must have attended at least 3 meetings.
5. Served as a certified league secretary for a minimum of 20 years (does not have to be continuous).
6. Served on local association committees for a minimum of 12 years (non-board members).
7. Served or worked for the state association, 500 Club, 600 Club, national committees, national board of directors or other affiliated organizations for a minimum of 6 years.

**If the above requirements have not been met, the applicant is not eligible for nomination.**

Forms are due annually by May 31. Forms received after that date will be held until the next nominating period. Nominees remain on the ballot for 3 years at which point they are removed if not inducted into the Hall of Fame. A person can be re-nominated. \*A bowler cannot nominate him/herself for the GBA USBC Hall of Fame.\*
