

GREEN BAY AREA USBC HALL OF FAME SUPERIOR PERFORMANCE NOMINATION FORM

PREREQUISITE FOR NOMINATION:

- Actively participated in the Green Bay Area USBC (or predecessor organizations) for a minimum of 20 years and reached the age of 50 (deceased members are exempt).

To qualify for superior performance, a candidate must have met the prerequisite above and have exhibited superior performance by accomplishing **at least 4 of the following**:

1. Holds at least one tournament title in any USBC sanctioned tournament. This includes national, state, or local tournaments.
2. Holds one scratch league championship.
3. Has been named to the GBA USBC All-Association team or to the 1st team on the Press-Gazette or News Chronicle All-City team.
4. Has a minimum number of sanctioned 300 games:
 - a. Men – 10 or more.
 - b. Women – 1 or more.
5. Has minimum number of sanctioned honor series:
 - a. Men – at least 5 800 series.
 - b. Women – at least 20 700 series.
6. Has at least one season with an outstanding average as defined below:
 - a. Men – a 60 game average of 230 or above.
 - b. Women – a 60 game average of 215 or above.
7. Held the Association High Average for at least 1 season.

If the above requirements have not been met, the applicant is not eligible for nomination.

Forms are due annually by May 31. Forms received after that date will be held until the next nominating period. Nominees remain on the ballot for 3 years at which point they are removed if not inducted into the hall. A person can be re-nominated. *A bowler cannot nominate him/herself for the GBA USBC Hall of Fame.*
